Motion Stoflet/Marten to approve the minutes from 9-14-20 as listed. Carried.

Referendums-Jamie Delikowski from Auburndale High School provided information on the school referendums. There will be two referendums on the 11/3/20 election. One is for \$200,000 recurring basis for operations. The second is for \$6.9 million for facilities improvements. The tax levy would increase \$.36 per \$1,000 if both were approved.

Police officer report- Edgard Gonzalez was present. He shared the police report. He issued several parking violation warnings. He followed up on grass/weed issues and animal control issues.

Financial report- Motion Anderson/Marten to approve the financial report as listed. Carried.

Joint meeting with Village, Town of Auburndale and Joint Fire Department at 8:00 p.m.

The village members remain the same. Town: Steve Seidl, John Bauer. Fire Dept: Todd Bores, Zac Weber.

The budget was presented. Town: \$41,418.00, Village: \$27,612.00. Motion Stoflet/Marten to approve the budget. Carried.

The fire department is in the process of updating their bylaws. There were 93 total calls, 51 EMS, 4 mutual aid, 5 fire, 15 car accidents, 6 good intent, 1 grass, 10 community service, and 1 carbon monoxide.

The department shared information on replacing a tank. Brian Hafermann from Stainless Repair was present. The estimated cost is \$387,380.00. This new truck is needed within 5 years. The current tank would be used as a backup truck. It would not be sold or traded. The new truck is a 2,000-gallon vehicle.

The fire department is doing a fund raiser this Saturday, October 10th. It is a pig roast, at the fire station, drive-thru only.
